IPR and the Blue Box Regulation

Individual producer responsibility (IPR) means that producers are responsible and accountable for collecting and managing their products and packaging after consumers have finished using them.

Key players in the IPR framework



Ontario Government (Ministry of the Environment, Conservation and Parks)

- Develops, approves and issues legislation
- Makes amendments to legislation, as required
- Issues direction letters



Resource Productivity and Recovery Authority (RPRA)

- Implements and enforces regulations
- Acts as a modern regulator and uses effective communication to achieve compliance
- Has power to take the following actions to ensure compliance:
 - Inspections and audits
 - Investigations
 - Compliance orders
 - Administrative penalty orders
 - Prosecutions

Key players in the IPR framework (cont.)



A **producer** is a person who supplies blue box material (packaging, paper products or packaging-like products) comprised of paper, glass, metal or plastic, or a combination of these materials to consumers in Ontario. The obligated producer for products and packaging is determined based on the producer hierarchies.

Producer Responsibility Organizations (PROs)

A PRO is a business established to contract with producers to provide collection, management and administrative services to help producers meet their regulatory obligations.

This can include arranging the establishment or operation of collection and management systems and preparing/submitting reports.

A **processor** is a person that processes Blue Box materials used in Ontario for the purpose of resource recovery. PROs and producers will have contracts with registered processors for the purposes of meeting management requirements.

Management requirements

A producer's management requirement is how much Blue Box material they must process into recovered resources each year (calculated based on what producers supplied into Ontario the previous calendar year)

Note: Some producers must report to RPRA but are exempt from management requirements (i.e., annual supply falls below the exemption threshold)

Curbside and Depot Collection System requirements

All producers with management requirements must establish and operate a curbside and depot collection system in Ontario.

- Communities currently receiving curbside collection must receive curbside collection
- Communities currently receiving depot collection must receive either curbside or depot collection.

What is a Supplemental Collection System?

A supplemental collection system is an optional system that is operated by a producer in addition to the curbside/depot collection system

 Materials collected can be used towards meeting a producer's management requirements

What is an Alternative Collection System?

An alternative collection system is a system that is operated by a producer <u>instead of</u> the curbside/depot collection system.

 Materials collected must be able to meet a producer's management requirements in a given year.

Promotion and education requirements

All producers and PROs who operate a collection system must implement a promotion and education program to educate Ontario residents (e.g., what can go in the curbside blue box).



Meeting your obligations

Producers with management requirements must have collection, management and promotion & education systems in place by **July 1, 2023.**

Working with PROs

If a producer chooses to work with a PRO to meet their obligations, they should have a contract in place with the PRO in advance of July 1, 2023, to ensure compliance with the regulation.

Establishing your own system

Any producer who is not planning to work with a PRO to meet their obligations should contact the Compliance and Registry Team to discuss how they plan to meet their obligations and ensure that they will be in compliance with the regulation.




What is a free rider?

1. Have not registered or reported to RPRA or have done so incorrectly

- 2. Have not established a collection and management system (if they are so required to)
 - Some producers do not have this obligation
 - Producers must identify who their PRO is to RPRA

3. Are not operating a collection and management system (if they are so required to).

Preparing for July 1, 2023

Producers need to determine how they will meet their obligations.

RPRA will be verifying system readiness, including individual producer readiness, leading up to **July 1, 2023**.



Upcoming dates and activities

Date/timing	Required activities
Within 5 days of signing a contract with a PRO	Producers need to log into their Registry account to indicate which PRO they have contracted with and for which services.
May 31, 2023	Deadline for producers to submit their 2023 Blue Box Supply Report (with 2022 supply data) through RPRA's Registry.
July 1, 2023	Producers must ensure they have collection, management and promotion and education systems in place.
Starting in 2024	Producers or PROs on their behalf must report annually to RPRA on their performance meeting their management requirements.
Starting in 2027 (and every three years thereafter	Producers or PROs on their behalf will be required to submit an audit verifying their performance reporting in the previous 3 years.
