

This document provides compliance guidance on annual reporting requirements for:

- Producers
- Producer responsibility organizations (PROs)
- Processors
- Retreaders
- Haulers
- Collectors

Introduction

The [Tires Regulation O. Reg. 225/18](#) requires tire producers, PROs, processors, retreaders, haulers and collectors to register with the Authority and to report specified information to the Authority annually.

There are two categories of annual reporting requirements:

- producer tire supply reporting
- producer resource recovery performance reporting

Producer tire supply reporting

All registered producers must report tire supply data on an annual basis. As part of registration in 2018, producers were required to provide tire supply data for the years 2014, 2015 and 2016, which was used to set their individual tire collection targets for 2019.

By May 31, 2019, all registered producers must provide tire supply data for the year 2017. This data, along with the previously reported tire supply data for the years 2015 and 2016, will be used to set individual producer collection targets for 2020. This process will be repeated each year, as set out in the table below:

* The collection target is calculated as 85% of the three-year average of the supply data

Tire supply data can only be reported by producers. It cannot be reported by a PRO on behalf of a producer. This data is not available to PROs from the Authority. It is up to a producer to provide its PRO with its collection target.

Producers will be required to pay their annual Registry fees as part of the reporting process. The Registry will open for annual reporting on April 1 of each year and the deadline for reporting will be May 31 of each year.

Resource recovery performance reporting

In addition to the requirement to meet a collection target, under the [Tires Regulation](#), each producer is required to meet a used tire resource recovery target of 85% of what a producer **actually collects**, or what a PRO collects on behalf of the producer. Recognizing that most producers will be contracting with PROs to meet their resource recovery targets, performance reporting can be done by producers or by their PROs.

Resource recovery can be met in three ways: processing, retreading and reuse.

In designing the performance reporting functionality for the Registry, two key questions were addressed:

- What data is essential for meeting the regulatory objectives of the Tires Regulation?
- Where the same information is required from different registrant categories, do both categories have to report it?

In answering those questions, Authority staff met with representatives of various registrant categories and visited processor and retreader sites to enhance their understanding of used tire logistics and develop an understanding of how used tires were tracked through the Ontario Tire Stewardship Treadmarks system. The Authority wanted to ensure that the reporting requirements to be developed in the Registry were efficient and minimized the impact on business while ensuring that compliance objectives would be met. To the extent possible, the Authority seeks to avoid reporting requirements that would require used tire market participants to change the way they currently handle used tires.

The Tires Regulation establishes four tire types:

- large tires – greater than 700 kg, per the [Registry Procedure – Weight Conversion Factors \(Tires\)](#)
- medium truck tires
- off the road tires, other than large tires
- passenger and light truck tires

Recognizing that:

- (a) the used tire industry does not generally segregate used tires into these four categories when handling used tires, and
- (b) the only category that has specific collection requirements is the large tire category (greater than 700 kg),

for the purposes of annual reporting, only two categories will be required for reporting in the Registry:

- tires greater than 700 kg (the large tire category)
- tires less than or equal to 700 kg (everything other than large tires)

Role-specific reporting requirements

Under the Tires Regulation, producers (or PROs on behalf of producers), processors, retreaders, haulers and collectors are required to report annually on their used tire performance.

The deadline for the first annual performance reporting is May 31, 2020.

The tables on the following pages provide a description of the key performance information that is required for each role.

Producers reporting directly, or through their PROs reporting on their behalf, that comply with the reporting requirements as established in the Registry will not be considered out of compliance. Until further notice, any of the reporting requirements in the Tires Regulation that are in addition to the requirements established in the Registry will not be enforced. This does not change any obligation to maintain records, which must be available for inspection as required.
