- a. All of the project area that the excess soil is to be removed from is an agricultural or other property use, or
 - b. All of the project area that the excess soil is to be removed from is parkland use, residential use or institutional use, or a combination of these three, and the soil will not be transported for final placement at a reuse site that is an agricultural or other use.
- I confirm that no portion of the project area is known by me to be affected by the discharge of a contaminant.
- 3) Documents were not prepared by a qualified person as the filing of this notice was not required by O. Reg. 406/19.
