



How to ask a question









Minister's direction

- Stewardship Ontario (SO) is the industry funding organization (IFO) that operates Ontario's Blue Box Program on behalf of industry stewards of packaging and printed paper
- On August 15, 2019, the Minister of the Environment, Conservation and Parks (MECP) issued direction to SO and RPRA to wind up the Blue Box Program and transition it to Ontario's new individual producer responsibility framework starting on January 1, 2023 through to December 31, 2025
 - SO will wind up as a corporation after the program wind-up has been fully implemented
- SO submitted its proposed wind-up plan to the Authority by the revised August 31, 2020 deadline set by the Minister
- It is expected that the Authority must review, consult on and approve the plan no later than December 31, 2020



Minister's direction on the CIF

"The Continuous Improvement Fund shall receive no additional contributions and shall end as soon as practical prior to December 31, 2025."

Background

The CIF

- Mandate stems from Section 6.6 of the BBPP
- Uses a proportion of the funds provided to municipalities under the BBPP to support projects intended to improve program performance
- Structured as a committee with equal representation from municipalities & producers
- Overseen by and reports to RPRA. RPRA approves CIF's annual operating plan and has final approval of the CIF Windup Plan




Background (cont'd)

- Minister's windup plan letter to RPRA included direction that:
 - CIF shall receive no additional contributions; and
 - End as soon as practical and prior to December 31, 2025
- Minister's letter to SO included direction to:
 - Develop a windup plan for the BBPP
- RPRA directed CIF to develop a windup plan (WUP) specific to its operations as part of the broader BBPP windup



CIF WUP Considerations

- Existing mandate
- Legal and financial funding obligations
- Stakeholder expectations and priorities
- Financial and administrative windup





Consideration: Existing Mandate

- BBPP remains in force subject to any amendments made through SO's WUP
- Mandate can, in theory, be amended to align the CIF with stakeholder's future needs

Legal Obligations & Mandate



Consideration: Stakeholder Expectations

- CIF undertook an extensive consultation process in developing its 3-Yr Strategic Plan (2019-2021)
- Municipal input prioritized:
 - Provision of transitional support;
 - Continuation of collective support in traditional areas of focus; and
 - Desire to revisit priorities if transition proceeded




Proposed: Strategic Priorities

- Transitional support
 - Research, cost modeling, contract support, asset valuations
 - Waste composition studies and data analysis
 - Performance case analytics
- Program Support
 - Procurement & contract management
 - Market research and development
 - Collection & processing technologies R&D
 - Working groups, training, online resources



Anticipated CIF Activity During Windup





Proposed: Administrative Windup

- CIF operations to year end 2023
- Windup of CIF's administration to begin in 2024 with an expectation that such activities will be completed no later than June 30, 2024
- Key windup activities include:
 - Asset management
 - Data management
 - Human resources

Consideration: Financial

- Last funding contribution was \$4.2M in 2016
- No additional contributions per Minister's direction
- As of September 2020:
 - Uncommitted funds: \$1.02M
 - Committed funds: \$9.29M
 - Forecasted surplus in 2024: \$.00
- The Windup Plan anticipates having sufficient funds to maintain operations through to year end 2025



Consideration: Legal and Financial Obligations

- 67 projects representing a combined obligation of \$7.6M were open at the time of development of the draft CIF WUP
- Majority completed by YE 2021

Legal Obligations & Mandate





Proposed Financial Windup

- \$3.7M in funds will be provided to M3RC through Municipal Collective Transition Fund
- \$3M in unallocated funds to be disburse to municipalities and First Nations in 2021
- Distribution of additional unallocated CIF funds to municipalities and First Nations in 2022
- A final possible disbursal to be made after all other CIF obligations are discharged in 2024

- The WUP notes that CIF will seek opportunities to continue providing access to these materials after its windup
- REOI has been issued soliciting interest from parties who may wish to maintain these assets
